

# Warranty

---

## Two Year Limited Warranty

Fastmount™ Ltd (the “Seller”) warrants to the Buyer that each product sold (the “Product”) shall (i) conform to the description or specifications stated on the face of the relevant price list and/or quotation, and/or packing slip, and/or invoice and (ii) shall be free from defects in materials or workmanship.

## Exclusions

Normal wear and tear does not constitute a defect. No warranty is valid unless the Buyer installs the Products using the Seller’s installation tools in strict conformance with the Seller’s installation guides. Any problem that is caused by failure to follow the Seller’s installation guides, abuse, misuse, alteration, accident, damage, vandalism, and/or use beyond the Product’s intended purpose is not covered.

## Warranty Period

This warranty is valid for two years from the date of purchase from the Seller (or an authorized distributor of Seller) for the original owner only and is not transferable.

## Remedies and Limitation of Liability

The Buyer’s exclusive remedy and the Seller’s sole liability hereunder shall be limited to a full refund of the purchase price of, or replacement of, all Products, at the Seller’s option, that Seller determines are defective and not subject to the exclusions above.

## Product Returns

Seller will repair or replace Products it determines to be defective provided the Buyer follows our Product return directions and pay return freight charges. Please note that replacement Product may not be exact due to upgrades and style changes to our Products.

If requested by the Seller, the Buyer shall promptly return to the Seller’s supplying plant all unconsumed goods alleged by the Buyer to be otherwise than as warranted and the Seller will pay freight thereon.

THE ABOVE WARRANTY IS IN LIEU OF ALL OTHER WRITTEN OR VERBAL, EXPRESS OR IMPLIED REPRESENTATIONS, WARRANTIES OR CONDITIONS. THE SELLER HEREBY EXPRESSLY DISCLAIMS AND EXCLUDES ANY AND ALL EXPRESS OR IMPLIED REPRESENTATIONS, WARRANTIES AND CONDITIONS AS TO MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

NO INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES ARE RECOVERABLE. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO THE BUYER

THIS WARRANTY GIVES THE BUYER SPECIFIC LEGAL RIGHTS AND THE BUYER MAY HAVE OTHER RIGHTS WHICH VARY FROM JURISDICTION TO JURISDICTION.
